BERNARD COMBRINK: Komeet vir die Koninkryk

Hans Jacob Bernardus Combrink is op 23 Oktober 1940 in Lydenburg, Transvaal gebore. In 1957 slaag hy matriek aan die Hoërskool Noord-Oosrand (Benoni) met ses onderskeidings. Daarna studeer hy in die Teologie aan die Universiteit van Pretoria, en verwerf die grade BA (1960), BD (1963) en BA Hons (Grieks - 1964), almal *cum laude*.

Op 4 Julie 1964 tree hy in die huwelik met Anna Lucia Antonites, 'n onderwyseres. Vier kinders word uit die huwelik gebore. In Desember 1965 voltooi hy die doktorale eksamen (ThDrs) aan die Vrije Universiteit (Amsterdam) met lof, en verwerf vervolgens die graad ThD op 17 Mei 1968. Sy proefskrif word in dieselfde jaar gepubliseer (Groningen: VRB), met as titel *Die diens van Jesus: 'n Eksegetiese beskouing oor Markus 10:45*.

In Junie 1968 slaag hy die Proponentseksamen aan die Universiteit van Pretoria met lof, en word kort daarna in die Ned Geref-gemeente Wonderboom (Pretoria) as leraar bevestig. Ná twee jaar in die bediening aanvaar hy in Augustus 1970 'n pos as senior lektor en hoof van die Departement Bybelkunde aan die Randse Afrikaanse Universiteit, Johannesburg (vir 3 jaar). Dit sou die begin wees van 'n veelfasettige bediening as akademikus oor meer as 30 jaar.

In Januarie 1974 skuif hy terug na sy *alma mater* (Fakulteit Teologie UP, Afd B) vir twee jaar, met leeropdrag Bybelkunde en die Nuwe Testament. In dié tyd word hy bevorder tot mede-professor in die Departement Nuwe Testament. In Februarie 1976 word hy beroep as senior lektor in die Nuwe-Testamentiese Wetenskap aan die Universiteit van Stellenbosch, waar hy in 1982 tot mede-professor bevorder word, en op 1 Januarie 1987 tot professor en hoof van die Departement Nuwe Testament. Later dien hy vir twee termyne as dekaan van die Fakulteit Teologie (1992-94 en 1998-2000), wat beteken dat hy vir byna 26 jaar voltyds aan hierdie fakulteit betrokke was. As dekaan tree hy op as pasaangeér in die delikate voorbereidingsfase tot gesamentlike teologiese opleiding vir die Verenigende Geref- en Ned Geref Kerke by die Fakulteit Teologie op Stellenbosch vanaf 2000. In 1992 ontval sy eggenote hom. Ongeveer twee jaar later tree hy weer in die huwelik met die weduwee Juliette Lambrechts.

Buiten sy akademiese- en bestuursverpligtinge was Bernard Combrink deur die jare by 'n ryk verskeidenheid kerklike aktiwiteite betrokke – onder meer as afgevaardigde na rings- en sinodale vergaderings en as lid (en voorsitter) van verskillende sinodale kommissies. Sedert 1990 is hy lid van die Kommissie vir Leer- en Aktuele Sake, en lid (en later voorsitter) van die Kommissie vir Bybelvertaling en Bybelverklaring van die Algemene Sinode. Tans is hy gemoeid met die vertaling van die Bybel vir dowes, asook die skryf van 'n kommentaar oor Matteus.

Combrink se navorsing en skriftelike nalatenskap strek oor 'n wye verskeidenheid *genres* en spesialiteitsveldel, waaronder narratologie, literêre kritiek, die Sinoptiese evangelies (veral Matteus), die prediking van Paulus (veral die Filippense-brief), Nuwe-Testamentiese teologie en etiek, tendense ten opsigte van Skrifinterpretasie (onlangs die sosio-retoriiese verstaan van Nuwe-Testamentiese tekste), Bybelvertaling, die rol van taal-handelinge by die lees van die Nuwe Testament, die kommunikasie van die Matteusevangelie in Afrika, die rol van stories in kinderpreke en kategese, asook talle eksegetiese studies met riglyne vir die prediking. Hy is outeur/mede-outeur en redakteur/mede-redakteur van vyf wetenskaplike boeke en 'n skool-handboek, 36 wetenskaplike artikels in plaaslike en oorsese tydskrifte, 30 hoofstukke in boeke, en 48 bydraes van 'n meer algemene en populêre aard (sien sy volledige publikasielyst elders in hierdie bundel).

Hy is steeds 'n aktiewe lid van verskeie professionele verenigings soos die Nuwe-Testamentiese Werkgemeenskap van Suid-Afrika, SACTE (SA Council for Theological Education), South African Academy for Religion, Society of Biblical Literature, *Societas Novi Testamenti Studiorum*, Tyndale Fellowship for Biblical Research, en die Suid-Afrikaanse Akademie vir Wetenskap en Kuns. Hierdie betrokkenheid sluit in dat hy gereeld by nasionale en internasionale kongresse optree. Hy dien op die redaksierade van *Neotestamentica*, *Skrif en Kerk*, *NGTT*, *Emory Studies in Early Christianity*, *Tydskrif vir Geesteswetenskappe*, asook die adviespanele van *Korean Christianity* en die WAT (*Woordeboek van die Afrikaanse Taal*). Hy tree ook op as redakteur van 'n kommentaarreeks op die Nuwe Testament (*KNT*).

Tydens sy loopbaan ontvang hy verskeie navorsingstoekennings om aan projekte by oorsese instansies te werk, onder andere by Pennsylvania Universiteit (Philadelphia), Graduate Theological Union, Berkeley (California), en Vanderbilt Universiteit (Nashville, Tennessee). Hierbenewens lewer hy verskeie gaslesings, onder andere in Tübingen en

Utrecht (Nederland), Cambridge (Engeland), Trondheim (Noorweë), Fort Worth (Texas), Praag (Tsjeggiëse Republiek), Claremont (California) en Tel Aviv (Israel). Onder sy leiding voltooи 56 meesterskandidate (MTh en MPhil) asook 16 doktorale studente (DTh) hul studies. Hy tree verder op as mede-promotor vir drie doktorale projekte en as eksterne eksaminator vir verskeie universiteite in Suid-Afrika. In 2000 verteenwoordig hy die Fakulteit Teologie (Stellenbosch) in Yogyakarta, Indonesië as teologiese adviseur by die Kommissie vir Teologiese Opleiding tydens die vierjaarlikse vergadering van die Ekumeniese Raad van Gereformeerde en Presbiteriaanse Kerke uit 24 lande.

Sedert sy afrede op 31 Maart 2001 is hy steeds betrokke by voortgesette teologiese opleiding en navorsing aan die Universiteit van Stellenbosch, onder andere as voorsitter van die Nuwe Testamentiese Navorsingsgenootskap aan die US, en as promotor vir etlike DTh-kandidate.

Machiavelli, omstrede Italiaanse skrywer en staatsman uit die sestende eeu, sou gesê het: "It is not titles that reflect honour upon people, but people upon their titles." Hoe dit ookal bedoel was om verstaan te word, sou ons vir Bernard Combrink om so 'n rede wil onthou – en by name vir sy integriteit en beskeidenheid as mens.

BERNARD COMBRINK: Comet for the Kingdom

Hans Jacob Bernardus Combrink was born on 23 October 1940 in Lydenburg, Transvaal. In 1957 he matriculated with six distinctions at North-Eastern Border High (Benoni). He then studied theology at the University of Pretoria, and attained the degrees BA (1960), BD (1963) and BA Hons (Greek, 1964), all *cum laude*.

On 4 July 1964 he married Anna Lucia Antonites, a schoolteacher. The couple had four children. In December 1965 Combrink completed with distinction, the doctoral examination ThDrs at the Vrije Universiteit (Amsterdam), and was issued the degree ThD on 17 May 1968. His thesis was published in the same year (Groningen: VRB), under the title *Die diens van Jesus: 'n Eksegetiese beskouing oor Markus 10:45 (The servitude of Jesus: An exegetic look at Mark 10:45)*.

In June 1968 he passed the final examination for the ministry at the University of Pretoria with distinction and was appointed as minister soon after, at the Dutch Reformed congregation of Wonderboom (Pretoria). In August 1970, after two years in the ministry, he accepted a position as senior lecturer and head of the department of Biblical Studies at the Rand Afrikaans University in Johannesburg. This heralded a multifaceted academic ministry of more than 30 years.

In January 1974 Combrink returned to his *alma mater* (the faculty of Theology, UP, Section B) for two years, to teach Biblical Studies and New Testament. In February 1976 he was appointed senior lecturer in New Testament studies at the University of Stellenbosch, where he was promoted to co-professor in 1982 and furthermore to full professor and head of the department of New Testament on 1 January 1987. He later served two terms as dean of the Faculty of Theology (1992-94 and 1998-2000), which indicates an uninterrupted period of almost 26 years' full-time involvement with this faculty.

During his latter term of deanship, Combrink piloted the delicate preparatory phase of a unified theological education for the Uniting Reformed and the Dutch Reformed Churches commenced at the Theological Faculty at Stellenbosch in 2000. In 1992 he was bereaved of

his wife. Roughly two years later he entered into a second marriage, with the widow Juliette Lambrechts.

Apart from his academic and administrative duties, Bernard Combrink was also involved throughout his career, with a rich variety of activities associated with the church – among these were representing his faculty at Circuit and Synod meetings and attendance as a member (and chairman) of various Synodical Commissions. Since 1990 he has been a member of the Commission for Education and Current Affairs and a member (later chairman) of the Commission for Bible Translation and Interpretation of the General Synod. He is at present involved in a translation of the Bible for the deaf, as well as writing a commentary on the book of Matthew.

Combrink's research and written legacy covers a variety of *genres* and specialised areas, including Narratology, Literary Criticism, the Synoptic Gospels (particularly Matthew), the preachings of Paul (particularly the Phillipians epistle), New Testament Theology and Ethics, Tendencies in Scriptural interpretation (recently the Socio-Rhetorical Understanding of New Testament Texts), Bible Translation, the Role of Verbal Actions in the reading of the New Testament, Communicating the gospel of Matthew in Africa, the Role of Stories in Sunday school and Sermons for Children, in addition to numerous exegetical studies with guidelines for preaching. He is the author/co-author and editor/co-editor of five scientific books and a school textbook, 36 scientific articles in local and foreign journals, 30 chapters in books and 48 contributions of a more general and popular nature (see his complete list of publications elsewhere in this collection).

He is still an active member of various professional societies such as the *New Testament Society of South Africa*, SACTE (SA Council for Theological Education), the South African Academy for Religion, Society of Biblical Literature, *Societas Novi Testamenti Studiorum*, Tyndale Fellowship for Biblical Research, and the South African Academy for Science and the Arts. This involvement includes his regular contributions at national and international conferences. He is on the boards of editors of *Neotestamentica*, *Skrif en Kerk*, *NGTT*, *Emory Studies in Early Christianity*, *Tydkrif vir Geesteswetenskappe*, as well as the advisory boards of *Korean Christianity* and the WAT (*Woordeboek vir die Afrikaanse Taal*). He also acted as editor for a series of commentaries of the New Testament (*KNT*).

During his career Combrink has received several research grants for research projects at foreign institutions, such as Pennsylvania University (Philadelphia), Graduate Theological

Union, Berkeley (California), and Vanderbilt University (Nashville, Tennessee). In addition, he has given guest lectures at Tübingen and Utrecht (the Netherlands), Cambridge (England), Trondheim (Norway), Fort Worth (Texas), Prague (Czech Republic), Claremont (California) and Tel Aviv (Israel). Under his leadership 56 master's students (MTh and MPhil) and 16 doctoral students (DTh) have completed their studies. He also acted as co-promoter in three doctoral projects and as external examiner for several universities in South Africa. In the year 2000 Combrink represented the Stellenbosch Faculty of Theology in Yogyacarta, Indonesia, as theological advisor at the Theological Education Commission during the four-yearly meeting of the Ecumenical Board of Reformed and Presbyterian Churches from 24 countries.

Since his retirement on 31 March 2001, he has remained involved in post-graduate theological studies and research at the University of Stellenbosch, notably as chairman of the New Testament Research Fellowship at the US, and as promoter to certain DTh candidates.

Machiavelli, controversial Italian writer and statesman from the sixteenth century, is known to have said: "It is not titles that reflect honour upon people, but people upon their titles." In whichever way it was meant to be understood, it is for such a reason that we wish to remember Bernard Combrink – in particular for his personal integrity and humility.
